INDEPENDENT AUDITOR'S REPORT

To the Shareholders and Board of Directors of Kreditimi Rural I Kosovës LLC

Opinion

We have audited the financial statements of **Kreditimi Rural i Kosovës LLC** (the "Company"), which comprise the statement of financial position as at December 31, 2022, and the statement profit or loss and other comprehensive income, statement of changes in equity and statement of cash flows for the year ended December 31, 2022, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the financial statements present fairly, in all material respects, the financial position of the Company as at December 31, 2022, and its financial performance and its cash flows for the year the ended in accordance with International Financial Reporting Standards.

Basis for Opinion
